

# Morgan County SWCD Seeding for Soil Health Program

## 2025 Application



**REQUIREMENTS TO APPLY**-For your application to be considered, it must meet the following criteria:

- ◇ Project must be within Morgan County
- ◇ Grant is only available to private landowners and non-governmental not for profit organizations. (Organizations that are publicly funded or are a taxing body are ineligible.)
- ◇ Project has not qualified for or received funding from another federal or state funded program

**I am applying to receive technical and financial assistance to:**

☐ **Install a Pollinator, Prairie, or other Native Habitat Planting**

(Pollinator plantings must be free of species that are noxious, invasive, and/or all amaranth. To verify that seed mixes are free of these species, the district will request the seed lab card from the distributor.)

☐ **Install a Buffer Strip, Filter Strip, Field Border, or Waterway**

☐ **Plant Cover Crops**

(For cover crop cost share programs, the maximum cost share is 75% of the total final cost of the practice, with 25% of the cost being the responsibility of the landowner, and a maximum dollar cap at \$30/ac. Seeding rates, planting dates, and seed tags will be required with the submission of receipts for reimbursements.)

If your application is considered for funding, a representative from Morgan County SWCD will be in contact with you to schedule a site visit of the project area to evaluate the conservation concern that funding is being requested for and begin the process of providing a conservation plan for you to follow. Once approved, you will be asked to sign an agreement with the SWCD. Funds will be reimbursed at 75%/25% rate based on receipts provided, up to a maximum of \$3,000 reimbursement. **Reimbursements of expenses will NOT be made on any work done or purchases made prior to SWCD board approval or without a properly signed agreement.** Any work done by the landowner or a representative of the landowner, that is not a professional company, cannot be billed for more than \$35 an hour for work done on a project and can only count towards in-kind match. Indiana Custom Farm Rates, published by Purdue Extension, annually, will be used to calculate in-kind match for equipment usage by participants for all in-kind match for projects. All funds will be reimbursed after the completion of the project, timely submission of all supporting documentation, and a final site review has been completed. **Conservation practices shall comply with USDA-NRCS Field Office Technical Guide specifications for that practice.** The applicant is responsible for locating underground utility location, obtaining all permits and complying with local ordinances, state statutes and federal regulation, if applicable.

*\*This program gives priority to participants who are installing a practice for the first time, installing a practice in a location for the first time, installing a practice adjacent to or near a waterway, and who intend to use no-till methods to plant. SWCD No-Till Drill rental fees will be reimbursed for those participants who choose to use the Morgan County SWCD No-Till Seed Drill, though a damage deposit will be collected and damage fees will apply if returned in poor condition. A separate drill rental agreement is required for use of the drill.*
